3. *Report re Sales Training and Recruitment Department*



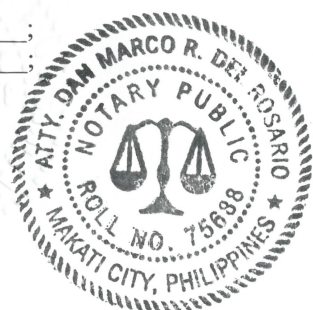


